Where can I get support with my SEND Tribunal appeal?

Legal Aid

If you are on a low income or receiving certain benefits, you may be eligible for legal aid. In some cases, a young person (aged 16-25) will qualify for legal aid in their own right.

The type of legal aid available in the SEND Tribunal is known as 'legal help'. A parent or young person eligible for this will receive support from a legal professional to prepare the case, and may also be able to obtain funding for additional evidence needed, such as reports from independent experts. Legal help does not cover having a representative to attend the hearing. However, in exceptional cases, a legal aid provider may be able to secure funding to represent you at a hearing.

If you are not eligible for Legal Aid, the SIAS Team may able to assist you.

SIAS (Southwark Information Advice Support) Team

SIAS Advisors can provide impartial individual advice and support for families who live in Southwark and are appealing to the SEND Tribunal. Our team will assess the level of advice and support you may require. If we have availability within our team, we will be able to support you throughout the Tribunal process – this may include representation at the Tribunal hearing. Our Advisors are not solicitors, but have training in SEN Law and may be able to assist your appeal.

Our Advisors work with parents to empower them to obtain the best possible result at their Tribunal. This may include advice and support with:

- The appeal and Tribunal process and what to expect
- Registering an appeal with the SEND Tribunal
- Preparation of papers for Tribunal
- The case management process
- Advice on evidence required
- The role of witnesses
- Working documents (where your appeal relates to the contents of an EHCP)
- Negotiation with the local authority
- Representation at your hearing

Parents remain in control of the Tribunal process at all times, and are responsible for making decisions about what they want the Tribunal to know about their child's needs, the support their child requires and the most appropriate educational placement for their child. Parents who are seeking support from the SIAS Team are reminded that Tribunal orders and deadlines remain their responsibility at all times.
